

AGREEMENT ON STUDENT EXCHANGE

BETWEEN

ORDU UNIVERSITY

AND

DALIAN MARITIME UNIVERSITY

This agreement is to promote the exchange of students and thereby partially implement the ideals expressed in the memorandum of understanding for academic cooperation between the two parties, concluded on (Date: 28/05/2025)

1. The Ordu University (hereinafter referred to as “OU”) and the Dalian Maritime University (hereinafter referred to as “DMU”) will exchange students under the following terms:

- 1.1 Nomination of exchange students

Each exchange student shall be nominated according to the relevant procedure and at the direction of the home institution. The host institution will admit exchange students according to its established policies and procedures.

- 1.2 Number of exchange students

The number of students to be sent from each institution will not exceed five [5] for each year. Two one-semester exchange students are equivalent to one full-year exchange student, balancing the total number of students over a period of five [5] full-year.

- 1.3 Duration

In principle, each exchange student will stay at the host institution for one full academic semester. However, the period of sending and receiving exchange students can be flexible, e.g. for one or more academic periods, based on the discussions between the two institutions.

- 1.4 Status of exchange students

The status of each exchange student at OU will be “non-degree exchange student” or “non-degree special research student.” The status of each exchange student at DMU will be “non-degree exchange student” or “non-degree special research student”.

1.5 Tuition exemption

The exchange program is based on the principle of reciprocity. The exchange students will remain enrolled at their home institution where they pay their tuition and other related fees. The host institution will exempt relevant fees for admission, examination and tuition for the exchange students.

1.6 Credit transfer

After the completion of the courses, the host institution will send an official academic transcript for each exchange student to their home institution. It shall be the sole responsibility of the home institution to decide how many transfer credit units the student may receive for courses taken at the host institution.

1.7 Regulations

Each exchange student will be subject to the same regulations as those pertaining to the students of the host institution. In case where an exchange student fails to observe the host institution's rules or regulations, the student must take full responsibility for their behavior. This may further lead to the reconsideration of this student's admission to this exchange programs.

1.8 Accommodation

In case university accommodation is not available, each institution will assist the exchange students in making room arrangements for the period of exchange. However, room charges will be the responsibility of the exchange students.

1.9 Expenses and insurance

Travel and other incidental expenses, as well as health and accident insurance will be borne by each exchange student. Exchange students from home institution who enroll in the program at host institution must obtain the national health insurance as well as additionally required insurances as designated by host institution. However, government and/or other scholarships may be used to cover these expenses.

2. Duration, amendment and termination

This agreement will come into force upon signature by authorized representatives of both parties and will remain in effect for a period of five (5) years. It may be terminated by either party giving twelve (12) months prior notice to the other party in writing, without prejudice to the completion of ongoing programs. The agreement may be amended by the exchange of letters between both parties.

2. This agreement is written in English and both parties retain one copy of the authentic texts.

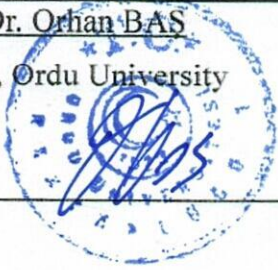

MEMORANDUM OF UNDERSTANDING FOR ACADEMIC COOPERATION

The Ordu University and the Dalian Maritime University, with the objective of fostering academic exchange and cooperation between the two parties, hereby agree as follows:

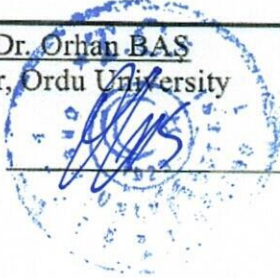
1. Both parties shall encourage the following activities in academic and educational fields in which they have mutual interest:
 - a. Student exchange at the graduate and/or undergraduate level;
 - b. Faculty and staff exchange;
 - c. Joint research activities;
 - d. Exchange of research results, academic publications and other academic information;and
 - e. Other academic exchange upon which both parties agree.
2. The implementation of each program based on this memorandum shall be negotiated and agreed upon by both parties under a separate agreement prior to the initiation of the particular program.
3. Both parties understand that all financial arrangements must be negotiated in advance and will depend on the availability of funds.
4. This memorandum will come into force upon signature by authorized representatives of both parties and will remain in effect for a period of five (5) years. This memorandum may be amended by the exchange of letters between both parties and may be terminated, with twelve (12) months prior written notice to the other party, without prejudice to the completion of ongoing exchange programs.
5. This memorandum is written in English, and both parties retain one copy of the authentic texts.
